President, Sherry Moody at 7:11p.m., called the meeting to order.

**Minutes:** The Minutes of the March 18, 2015 meeting had been emailed or mailed to all Board members. Maggie Birch made a motion to accept the minutes as written. There was a second. The motion passed.

**Treasurer's Report, Finance:** This month's Treasurer's report reviewed the budget results for First Quarter, 2015. The report had been emailed to all Board members. Overall, our financial results for the quarter are ahead of budget expectations by almost \$500. There are some significant variations that to be noted.

#### INCOME:

- 1) The Spring Luncheon reservations are below our estimates and history. Only 33 reservations to date (4/12/2015) and 5 are comp. faculty.
- 2) We are about \$700 below budgeted donations to date. More donations have arrived since end of the quarter.

#### **EXPENSES**:

- 3) The Logo Committee has not made the first quarter purchases to replenish stock.
- 4) The Kuay expenses for the winter issue are a bit lower (\$370) than budgeted.

The organization is sound. The Board does need to look carefully at our events category. Perhaps adjustments need to be made to increase participation and/or reduce risks to the budget.

**<u>Old Business</u>**: We still need to have a volunteer come forward to take the July and possibly August Board minutes. There will be no meeting during June.

**New Business:** Broadway Pride. A video history of Broadway High School. Seattle's first high school. Was seen every Saturday in 2014 at 8 pm on SCCtv, Comcast Channel 28/Wave

Do we want to make video about Queen Anne HS, similar to Broadway HS? We had some discussion but nothing was decided.

Our By-laws allow us to change the date of the Annual Meeting. Suggestion – Let us change the date to the Spring Luncheon, and eliminate the Fall Luncheon in 2016. There was discussion about the change and how it would affect Board members term of office. There was no vote was taken at this time. More discussion will be needed on this subject.

**Membership:** There were 600 address corrections to the Kuay. LD noted the mail returns of the Kuay are down, which is good.

**Scholarship:** There were 50 application received. The Committee will meet Friday April 17<sup>th</sup> at 8:00 am. There are 30 scholarships to be awarded at \$500 apiece.
