Via ZOOM October 21, 2020

The meeting was called to order by President, Sally Villaluz Ghormley at 7:13 P. M.

Scholarship: Kerry was on speaker phone via Sally and presented his request from the Scholarship committee to the board:

"Our normal selection process is to meet and review all applications, discuss the merits of each and select the winners. Some years we have many applicants and other years, very few. The process typically takes 2 to 3 hours. This year, the board has authorized 30 scholarships. We have received 35 applications Three applicants have withdrawn. We are left with 32 excellent applicants. The lowest grade point average is 3.01, however the applicant has a very inspirational story and is deserving of a scholarship.

Please consider this a **formal request** to for the board to:

- a) give the committee two additional scholarships for 2020; and
- b) give the committee authority to not award any scholarships in 2021.

L.D. had concerns regarding funding of the additional scholarships since donations are currently down \$4600. and also asked for clarification regarding which year we are requesting to NOT award scholarships. The committee clarified that the board has already approved awarding 30 scholarships to the students that applied in March 2020 and that we are seeking 2 additional scholarships to award all 32 applicants from the Spring of 2020 who are currently attending school either online or in person and that we wish to accept NO applications in the Spring of 2021, resuming the process again in the Spring of 2022 – pandemic permitting.

Mike stated that he thinks we should trust the scholarship committee and award 32 scholarships for 2020.

A motion was made by Maggie Birch and seconded by Roger Jensen that we approve an additional 2 scholarships for 2020 for a total of 32 and that we do not award scholarships in 2021. All present members agreed.

<u>Minutes:</u> A motion was made by Claudia Lovgren and seconded by Maggie Birch to approve the minutes of the September 16, 2020 board meeting. All present members agreed.

<u>New Business - Annual Meeting Election of Board Members:</u> We need to re-elect the board members whose 3-year term has ended and consider a new member of the board.

A motion was made by Roger Jensen and seconded by Mary Cooke that we re-elect the four board members that are up for re-election as well as the newly proposed board member, Jan Jenkins. All present members agreed.

<u>Treasurer's Finance Report:</u> L.D. Zobrist and Claudia Lovgren presented the Treasurer's report that was emailed to all board members:

This month we review our budget results for three quarters. Overall at this point we are near break- even, but this is misleading, since we have not issued our scholarship payments for 2020.

Looking first at income, we are about \$4,600 behind our budget for scholarship donations at \$9,500.

Remember the Board approved a budget increase in payment to \$30,000 for the year. The functions income is zero because of canceled events, but our functions expenses are almost zero as well to balance out. For the good, we are over \$2,000 ahead on general fund donations and on dividend income each.

On the expense side, the only standout besides the near-zero function expenses, we have not purchased as much logo merchandise this year, since events and reunions have been canceled.

At the November meeting, the Board is scheduled to approve the 2021 Budget.
