Treasurer's Finance Report: L.D. presented a review of General Operating Fund cash flow. We have received revenue in the amount of $\$ 8,213.00$ mostly from donations and logo sales. Our expenses are from the production and mailing of the KUAY newsletter in February, 2021. Post Office Returns from the KUAY mailing, plus shipping logo items and bank fees for PayPal. Our net income is slightly more than break even. This means our revenue for this period offsets the cost of our newsletter, and much of the revenue is a result of the newspapers publication.

- We have sent address verification emails to over 4,600 alums and have received about 200 responses with address and/or phone number updates that we are working to post before the KUAY mailing.
- We are working with a number of reunion committees as they plan and notify classmates, and we are requesting website updates to the reunions page as information changes.

Scholarships: Sally talked to Kerry and invited him to our in-person meeting on August 4. He has agreed to join us and we will discuss Scholarships first at the meeting.

Social Media: Mary posted on one of the Alumni Facebook pages about the upcoming KUAY and let people know where to send their info if they are not currently receiving the KUAY. The post had received 65 "likes". Then that FB page was switched from Public to Private. Sally asked a question about why the change was made, received an answer about the Alumni Association having a different page - which she asked for details about - and that answer was then deleted. Sally will contact the Administrator, Susan Masterson Lundh directly to see if she can get an answer.
