President, Sally Villaluz Ghormley called the meeting to order at 6:43 P. M.

Minutes: A motion was made by Jeanne Warren and seconded by Shirley Kankelfritz, to approve the minutes of the June 22, 2022 Board meeting. All present members approved.
Treasurer's Report: QAHSAA August 2022 Treasurer's Report for the Board
This month we will examine the Budget Report for the completion of the second quarter, 2022 ending June 30. Presented is the budget report for that period.

On the income side, we have received more donations, both scholarship and general, than expected (budgeted) for this point in the year, given the summer KUAY did publish until July. Our investment dividends are over $\$ 1,100$ higher than expected. This has given us an almost $\$ 11,000$ advantage at this point of the year. We did not budget for a Spring Luncheon for this year because of the Pandemic, so had over $\$ 3,800$ in Spring Luncheon funds come in against a zero budget, but this was offset by the SYC expenses shown on the Expense side of the report.
**In person - Final expense for the yacht club luncheon after much back and forth, most of which ended up in our favor - from an initial invoice of $\$ 3,759.00$ to a final invoice of $\$ 2203.00$.**
Yearbook Sales budget item is no longer valid as year book sales - they are now part of Logo Sales, so we will consolidate that item in future reports. Finally, On the expense side, the two large difference are the Spring Luncheon costs that were not budgeted for this year and the underspending of replenishment of Logo Merch. stock, mostly offsetting each other.
In summary, we are about $\$ 13,500$ positive compared to our budget through second quarter and are in excellent financial status.
